Chadron State College is considered a FAR (Frontier and Remote) institution. It is located in a sparsely populated, geographically isolated, economically challenged portion of the United States. A majority of the graduates of the CSC program will teach in rural communities within Nebraska, Wyoming, and South Dakota. Therefore, rural education concepts, elements and strategies are infused within the curriculum. Likewise, the students are provided experiences allowing practices within this environment. The assessment results indicate that the students are prepared at a proficient level for working within this geographic environment. The education program has increased hours in the instruction of classroom management.

The professional education curricula provide learning experiences for using technological applications and strategies to enhance instruction and student learning (1) within specialized coursework, (2) infusion into methods courses,(3) through observation and participation in school settings and (4) during the student teaching experience. The program annually collects information from our student teachers and their cooperating teachers on the effectiveness of the program in preparing them to utilize technology. We then review that data and adjust the curriculum to address any areas that show need for improvement.
